

**WARH - 106.5 The Arch 12 Days Of A Very Courtney Christmas Sweepstakes  
Official Rules**

**NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.**

**BY ENTERING THE SWEEPSTAKES, EACH ENTRANT AGREES TO THESE OFFICIAL RULES.**

- 1. Eligibility:** The WARH - 106.5 The ARCH 12 Days of A Very Courtney Christmas Sweepstakes (the "Sweepstakes") is open only to listeners who are 18 years or older and residents of Missouri and Illinois and have a valid passport as of the date of entry. In order to be eligible to win a prize in this Sweepstakes, you cannot have won any prize within thirty (30) days prior to the awarding of a prize to you in this Sweepstakes from any Hubbard Radio St. Louis station (KSHE-FM, KPNT-FM, 106.5 The ARCH, 101ESPN, 92.3 WIL). These restrictions apply even if you reject the prize. Void outside of MO, and where prohibited by law. No purchase necessary to enter the Sweepstakes. Employees of Hubbard Radio St. Louis, LLC and its station 106.5 The ARCH, 11647 Olive Blvd., St. Louis, MO 63141 (the "Sponsor"), WonderLights Christmas, The Fox Theatre, Cutco Knife Class, Tony's on Main Street, St. Louis Blues, YogaSix, St. Louis Cardinals, MassageLuXe Spa, and the Gateway Region YMCA (collectively, the "Promotional Participants"), Hubbard Radio, LLC, or any of their respective affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production execution or distribution of the Sweepstakes (collectively with Sponsor and Promotional Participants, the "Released Parties") and their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members of each such employee are not eligible to enter or win. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- 2. Sweepstakes Period:** The Sweepstakes begins at 12:00:00 AM Central Time ("CT") on December 1, 2021 and ends at 11:59:59 PM CT on December 16, 2021 (the "Sweepstakes Period"); and includes an on-air entry period and an ARCH Rewards entry period.

The on-air method of entry period occurs each weekday (Mon-Fri) during the Sweepstakes Period, beginning at 7:40 AM CT and ending at 8:40 AM CT that day (each, an "On-Air Entry Period"). The ARCH Rewards method of entry period occurs each weekday (Mon-Fri) during the Sweepstakes Period, beginning at 12:00:00 AM CT and ending at 11:59:59 PM CT that day (each, an ARCH Rewards Entry Period").

- 3. How to Enter:** There are two (2) ways to enter for a chance to win during the Sweepstakes Period.

  - a. On-Air:** To enter via the on-air method of entry, listen to The Courtney Show during each On-Air Entry Period for the Courtney Christmas Code Word to be read at or about 7:40 AM CT each weekday (Mon-Fri) during the Sweepstakes Period. Then, listen around 8:40 AM CT that same day for the cue-to-call. Once you hear the cue-to-call, be the 12<sup>th</sup> caller to call into and reach the station by calling **314-969-1065** with that day's correct Courtney Christmas Code Word, and you will be that day's Daily Prize winner. Odds of being a Daily Prize winner depends on the number of listeners calling after the cue-to-call is announced each day who know that day's correct Courtney's Christmas Code Word. By calling into the station to attempt to become a Qualifier, each entrant understands and agrees to allow the call to be recorded and/or aired on the Station. Anyone calling in who does not know that day's proper Courtney's Christmas Code Word will be disqualified and an alternate caller may be

selected, time permitting. There will be a total of twelve (12) On-Air Daily Prize winners during the entire Sweepstakes Period (one per weekday).

Note that webcasts of 106.5 The Arch programming are typically on a delayed basis, which may affect a webcast listener’s ability to participate in this Sweepstakes. Sponsor will not accept collect calls. Sponsor is not responsible for telephone line unavailability, busy signals on the Sweepstakes line, operator interference, technical or atmospheric conditions that disrupt the completion of the phone call, telephone system malfunctions, or any other telephone problems which may or may not result from this Sweepstakes. By calling into the station to attempt to become a Qualifier, each entrant understands and agrees to allow the call to be recorded and/or aired on the Station.

- b. **ARCH Rewards:** To enter via the ARCH Rewards method of entry, open the ARCH stream player available online at [www.1065thearch.com](http://www.1065thearch.com) or through the ARCH mobile app (collectively, the “App”), find the Prize Details page and compete and submit the Sweepstakes official entry form. Please note: you must be registered through the App to be eligible to enter. Limit of one (1) entry per person per day. All entries must be received by 11:59:59 PM CT each weekday during the Sweepstakes Period, or by 11:59:59 PM CT on December 16, 2021 to be eligible for the last day’s random drawing. Sponsor is not responsible for lost, late, delayed, incomplete entries.

**HOW ARCH REWARDS DAILY PRIZE WINNERS ARE SELECTED:** Then, on or about the weekday following each ARCH Rewards Entry Period, Sponsor will randomly select one (1) Daily Prize winner via a random drawing, from among all eligible ARCH Rewards entries received up until that random drawing. Sponsor will notify the potential Daily Prize winner’s via email or telephone on or about the day of the random drawing. If Sponsor is unable to reach any potential Daily Prize winner after making two (2) attempts, that potential winner may forfeit their right to a Daily Prize, and an alternate may be selected, time permitting. Any non-winning entries from any random drawing WILL roll over to subsequent random drawings. Odds of being selected as a Daily Prize winner depends on the number of eligible entries that are received up until each random drawing occurs.

Limit one (1) Daily Prize per person during the entire Sweepstakes Period. This is to verify that the prize is being given to the qualified winner. Failure to comply with any deadline set forth in these official rules shall be deemed to be the winner's forfeiture of his or her right to claim a prize. If required by Sponsor, a winner must prove he or she is a qualified winner by presenting identification acceptable to Sponsor (e.g., state driver's license; state issued identification card; valid passport with address verification; or birth certificate with social security card and photo identification and address verification). If a winner cannot prove he or she is a qualified winner, the prize will not be awarded. Any unclaimed prize remains the property of Sponsor.
  
6. **Participation Conditions/Release/Consent to use Likeness:** By participating, each participant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Sponsor which are binding and final in all matters relating to this Sweepstakes; (b) release and hold harmless the Released Parties from and against any and all claims, expenses, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's participation in this Sweepstakes, participation in the Sweepstakes, and acceptance or use or misuse of prize ; (c) indemnify, defend and hold harmless the Released Parties from and against any and all claims, expenses, and liabilities (including reasonable attorney's fees) arising out of or relating to an entrant's participation in the Sweepstakes and/or entrant's acceptance, use or misuse of prize; and (d) allow Sponsor's use for promotional purposes, of his/her likeness, voice (including a recording of the winner's telephone call to the station) and/or address (city/state) without any additional

compensation. By calling in to participate in this Sweepstakes, each participant consents to his or her voice and telephone conversation being recorded and/or broadcast.

7. **General Conditions:** Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, for any reason whatsoever, including, without limitation, fire, flood, natural or man-made epidemic of health of other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal state or local government law, order, or regulation, public health crisis, order of any court or jurisdiction or if any fraud, technical failures or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in its sole discretion. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the participation process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Only the type and quantity of prizes described in these Official Rules will be awarded. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
8. **Limitations of Liability:** The Released Parties as set forth above are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Sweepstakes; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the participation process or the Sweepstakes; (4) technical or human error which may occur in the administration of the Sweepstakes or the processing of phone calls; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use or misuse of any Prize.

All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with this Sweepstakes shall be governed by, and construed in accordance with, the laws of the State of Missouri, USA without giving effect to any choice of law or conflict of law rules (whether of State of Missouri, USA or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Missouri, USA.
